PLANNING FOR TOMORROW

We understand that when you and your family are planning your estate, you want to provide for the people, organisations and causes you love. If you make a gift to State Theatre Company South Australia, there are a number of ways you can express your special bequest intentions.

You may specify to leave the Company a specific gift which could be a fixed sum of money or a specific item, a percentage share of your estate, or the remainder of your estate in the form of a residuary gift.

If you already have a will, you can simply amend it to include a gift to State Theatre Company South Australia.

Before making a gift, we recommend that you seek professional legal advice.



SUGGESTED WORDING FOR YOUR WILL

If you are considering making a bequest to State Theatre Company South Australia, the following clauses may be of assistance for inclusion in your will when discussing this matter with your solicitor.

A bequest of percentage of your residual estate:

I GIVE to STATE THEATRE COMPANY OF SOUTH AUSTRALIA (ABN 55 386 202 154) free of all duties [in words] percent of my residual estate and I DECLARE that the receipt of the proper officer for the time being is a sufficient discharge to my Trustees.

A bequest of an absolute sum:

I GIVE to STATE THEATRE COMPANY OF SOUTH AUSTRALIA (ABN 55 386 202 154) free of all duties the sum of [amount in words] DOLLARS (\$X) and I DECLARE that the receipt of the proper officer for the time being is a sufficient discharge to my Trustees.
